Membership:

Section 1. The amount of the Initiation Fee, other than stock purchase in Van Duzen Land & Development Company, shall be set by the Board of Directors. The following classes of membership are available:

| Family        | -Includes spouse and single dependent children through the age 20. Age limit extends through the age of 23 if dependent child is a fulltime student. ***  |
| Single Person | -An individual membership for persons who have attained at least age 26, are not married and have no dependent children living with them. Monthly dues are 75% of Family Monthly Dues.  |
| Senior Single | -An individual membership for persons age 65 and over who are not married and have no dependent children living with them and have been a member of the Club for at least five years (60 months). Monthly dues are 50% of Family Monthly Dues.  |
| Junior        | -An individual membership for persons age 12 through 25 who are not married and who have no dependent children living with them. Fifty percent (50%) of the current Initiation fee is due with the application and the monthly dues are 50% of the Family Monthly Dues. Upon attainment of age 26, member must have a share of Van Duzen Land Development stock or pay fifty percent (50%) of the then current Initiation fee to maintain membership. |
| Social        | -Entitled to all Club privileges and use of the swimming pool. Golfing privileges includes one day per month per family member. Golfing more than one day per month will require payment of the regular green fee each time of play. Monthly dues are 50% of Family Monthly Dues.   |

General: Membership may be attained by the purchase of a share of stock in Van Duzen Land Development Or, by payment of an Initiation Fee only of \$500.00 or \$250.00 if for a Junior membership.

**Initiation Fees are non-refundable.**

Withdrawal or leave of Absence: Any member intending to withdraw from the Club must notify the Club in writing, and will forfeit any claim to all initiation fees paid to the club. Members may request a leave of absence for no less than a twelve (12) month period, nor for more than a twenty-four (24) month period. Beginning with the twenty-fifth (25) month of absence, the membership shall be canceled unless member has applied for an extension and has been granted such by approval of the Board. A member may re-enter before the minimum twelve (12) months have elapsed, but must have Board approval and make payment of all dues back to the date of withdrawal. All other approved leaves of absence will pay a re-in statement fee of one (1) months dues upon returning to active membership. If you choose to terminate your membership and then rejoin the Club within 12 months of termination, you will be subject to the following rules. 1) Must complete membership application. 2) Must pay a reinstatement fee, equivalent to and not less than, 12 months dues at your classification at the time you terminated your membership.

It is the responsibility of each member to keep the Board of Directors informed of any changes that might affect membership classification.

\*\*\* In the unfortunate case of a divorce, the membership can be retained by only one spouse. In the case of a family membership that ceases to become a family, there shall be one succeeding primary membership as determined by the family. The second member may join at half the current initiation fee. The family shall determine which member shall remain family and which will have to become a single membership.
